## Pleasant Run Practice Soccer Field Rental Policies

## Fees and refunds

- 1. City related functions shall have first priority in the city's parks and shall use these parks without charge.
- 2. The city does not charge a fee for practice soccer fields for youth sports associations and residents.
- 3. Commercial or organized teams or teams playing fames other than those scheduled by the city's recreational sports associations, shall be required to a pay a fee, as established by the parks and recreation department. Field reservations are required for such teams.
- 4. Refunds are available due to inclement weather, provided however, that a request for a refund is submitted to the Parks and Recreation Department, in writing, within one week of scheduled session. Failure to submit a timely request for a refund forfeits the refund. Rescheduling in lieu of a refund is permitted based upon availability of time slots.

## **Reservations**

5. Practice fields are available on a first-come first-serve basis. Local sports associations and teams have priority. Any person or team found to be violation the terms of this policy shall be denied access to the practice fields for the remainder of the season.
